Overview: Chatham County maintains a comprehensive mosquito control program with a fiscal year operating budget of approximately \$4,000,000. The program serves the entirety of Chatham County including all of unincorporated Chatham County and eight municipalities including the City of Savannah, an area of approximately 440 square miles with 278,000 residents. The Chatham County Mosquito Control Department operates with 29 staff positions. The Department also maintains four helicopters and these aircraft are the primary instruments used for mosquito control efforts as well as surveillance in remote areas. Mosquito Control aircraft are additionally used to support local police and fire departments, Emergency Management, and a number of other county departments and agencies. Professional development is strongly encouraged and the department's staff actively participate in the American, Mid-Atlantic, Georgia, South Carolina, and Florida Mosquito Control Associations.

Job Summary: Under general supervision of the Mosquito Control Director, supervises the daily operations of the department. Assists the Director in planning and implementation of an Integrated Mosquito Management Program. Assists with budget planning and implementation. Assists the Director with personnel management. Interacts with county departments, public and private agencies, vendors, and the public to provide assistance and obtain cooperation in implementing the Mosquito Control Department's plans and procedures.

Minimum Qualifications: Bachelor's Degree in Entomology, Public Health or related field required; supplemented by three (3) or more years of experience in the management and/or supervision of a Mosquito Control or related program; or any equivalent combination of education, training, and experience which provides the requisite knowledge, skills, and abilities for this job.

Specific License(s) and/or Certification(s) Required: Must possess and maintain a valid driver's license. Must possess, or within 6 months of beginning employment, acquire and maintain a valid Georgia Pesticide Applicator's License in Public Health, Aerial, Demonstration and Research, Right-of-Way, and Aquatic Pest Control categories.

Note: During emergencies and disasters affecting Chatham County, you may be required to report to work as part of a disaster operations team.
